Responsibilities of Squads In-charge of Anti Ragging Committee

On receipt of the recommendation of the Anti Ragging squad or on receipt of any information concerning any report incident of ragging the Head of Institution/Principal shall immediately determine the case under the penal laws is made out and if so, either on his/her own or through a member of the Anti Ragging Committee authorized by him/her in the behalf proceed to file a First Information Report (FIR) within 24 hours of receipt of such information or recommendation with the police and local authorities under the appropriate penal provision relating to one or more of the following namely:

1. Abetment to ragging
2. Criminal conspiracy rag
3. Unlawful assembly created
4. Public nuisance created during ragging
5. Violation of decency and morals through ragging
6. Injury to body, causing hurt or grievous hurt
7. Wrongful restraint
8. Wrongful confinement
9. Use of criminal force
10. Assault as well as sexual offences or unnatural offences
11. Extortion
12. Criminal trespass
13. Offences against property
14. Criminal intimidation
15. Attempts to commit any or all of the above mentioned offences against the victim (s)
16. Threat to commit any or all of the above mentioned offences against the victim (s)
17. Physical or psychological humiliation
18. Other inference following from the definition of "Ragging"
