Responsibilities of Squads In-charge of Anti Ragging Committee

n concerning any On receipt of the recommendation of the Anti Ragging squad of on re of any info report incident of ragging the Head of Institution/Principal shall immediately desermine is ase under the penal laws is made out and if so, either on his/her own or thorough a member of the Ami Rag ing Committee authorized by him/her in the behalf proceed to file a First Information Report (FIR) within 24 hours of receipt of such information or recommendation with the police and local authorities under the appropriate penal provision relating to one or more of the following namely:

- 1. Abetment to ragging
- Criminal conspiracy rag
- 3. Unlawful assembly created
- 4. Public nuisance created during ragging
- 5. Violation of decency and morels through ragging
- 6. Injury to body, causing hurt or grievous hurt
- Wrongful restraint
- Wrongful confinement
- 9. Use of criminal force
- 10. Assault as well as sexual offences or unnatural offences
- 11. Extortion
- -12. Criminal trespass
- 13. Offences against property
- 14. Criminal intimidation
- 15. Attempts to commit any or all of the above mentioned offences against the victim (s)
- 16. Threat to commit any or all of the above mentioned offences against the victim (s)
- 17. Physical or psychological humiliation
- 18. Other inference following from the definition of "Ragging
